IT ALSO PROVIDES OPEN AND CLOSED SUPPORT GROUPS FOR WOMEN AND CHILDREN SURVIVORS OF DOMESTIC VIOLENCE. IN FY19, PATHWAYS SERVED 2,135 SURVIVORS OF VIOLENCE.

ADA'S PLACE HOUSING PROGRAM: PROVIDES TRANSITIONAL HOUSING FOR UP TO 18 MONTHS IN AN INDEPENDENT LIVING PROGRAM TO PROMOTE GROWTH AND SELF-SUFFICIENCY AMONG HOMELESS SINGLE WOMEN WITH OR WITHOUT CHILDREN. EMERGENCY HOUSING IS ALSO OFFERED UP TO 30 DAYS FOR HOMELESS FAMILIES WHO ARE COMMITTED TO SEEKING STABLE, PERMANENT HOUSING. THE GATEWAY CENTER PROVIDES ASSESSMENT, REFERRAL AND EMERGENCY SUPPORTIVE SERVICES FOR INDIVIDUALS AND FAMILIES. IN FY19, ADA'S PLACE SERVED 242 FAMILIES THAT INCLUDED 280 ADULTS AND 160 CHILDREN.

PROGRAM STAFF OFFER CASE MANAGEMENT SERVICES TO CLIENTS AS THEY TRANSITION FROM SUBSIDY ASSISTANCE TO SUSTAINABLE UNSUBSIDIZED LIVING AT THE COMPLETION OF THE PROGRAM. IN FY19, RAPID RE-HOUSING SERVED 72 FAMILIES THAT INCLUDED 79 ADULTS AND 106 CHILDREN.
